2. Will we deal with surplus monies before consolidation? Will we wait until we consolidate and turn our monies over to the other district?	Surplus monies will be spent on things that will put our schools in good physical condition
3. Is there a final date for consolidation to occur? Will people be hired and then released after consolidation?	3 years until consolidation. (2019-20, 2020-21 and 2021-22). New Board will be elected 1-1-2021
4. What is the course of action for picking the individuals that will be a part of the consolidated district?	Individuals to be considered as part of the consolidated district – SIC, PTA, Catch the Wave members
5. What type of consolidation are we looking at?	Shared consolidation initially and then full consolidation.
6. What will happen to the buildings in our community?	Would like to leave elementary and middle schools as is and consider building one high school
7. Will our kids go to Hampton schools?	Would like a consolidated high school and other students will remain in the district
